3. Continuing students must complete their semester registration as per the Semester Registration Policy.

5. Students shall be responsible for all signed undertakings even if the same has been signed by the parent/local guardian. All undertakings and documents mentioned in the application checklist for local and international students should be completed as per the deadlines, inability to complete before the deadline will result in cancellation of conditional admission.
6. Convocation fee of 4500/- VAT 5% will be additional payable in the final year of the program.
7. Transportation fee is additional, refer miscellaneous fees.
8. For all payments against Tuition fees and miscellaneous fees refer to HUC Financial Policy 2025-2026.
9. The current fee structure and the payment plan do not include the summer semester. If a student wishes to register in the summer semester, they must contact the SSD department to apply. Upon approval, the student will be issued a new payment plan by the Finance Department and the same will be updated on the student portal.
10. All rights and obligations of Skyline University College are transferred to Horizon University College.
